Re: October 9, 2019 Letter to Mr. David Slayton

Mr. David Slayton and Ms. Mena Ramon have referred to us the attached October 9, 2019 letter styled "Petition for Review as a result of denial of public records request (Appeal No. 17-010)." In that letter, you assert that Ms. Ramon denied you access to records regarding Rule 12 Appeal No. 17-010 and failed to provide you a copy of our denial of your request that we reconsider Appeal No. 17-010 under our October 13, 2017 case records directive. All records maintained by OCA staff, including Ms. Ramon, related to Rule 12 appeal matters are records of the presiding judges of the administrative judicial regions. Thus, we are responding directly to you regarding the matters you raise in your October 9, 2019 letter.

Regarding your request for the notices sent under Rule 12.9(e) and (f) related to Rule 12 Appeal No. 17-010, we previously confirmed, and Ms. Ramon has informed you that none exist. Regarding your request for a copy of our denial of your September 24, 2019 request to reconsider your 2017 appeal under the October 2017 case records directive, on October 2, 2019, Ms. Ramon sent you the attached email informing you that we would not address your "appeal" because it had already been reviewed by a special committee and that re-reviewing your "appeal" would not change the outcome. That email, which specifically notes that it was sent under our direction, constituted our denial of your request that we process your appeal under the case records directive.

This letter addresses and is our final action and response regarding: 1) all issues you have raised and allegations you have made in your attached October 9, 2019 letter, 2) any issues regarding the processing, review, and issuance of Rule 12 Appeal No. 17-010, and 3) the denial
